 - ii. We are still using a Raspberry Pi running software and same power supply. The radio is still running on my coax and antenna at my home so far.
 - iii. The VOIP device is now a DINAH (see below) and NARS Yaesu FT8800 (see below). The change has seemed very positive so far and seem more stable. The FT8800 remote base is a dual band radio, so we can run it on 444.375 or 146.66. Currently it is on 444.375, but can be easily switched with a touch of a button.
 - iv. Next Repeater Committee meeting is not yet planned
